



Carpet Extraction Shampoo Plus Cherry

Cleanline® Carpet Extraction Cleaner Plus Cherry is a concentrated, premium and highly perfumed shampoo that effectively cleans carpets and upholstery.

- Low foaming and highly perfumed carpet cleaner will remove dirt and general soiling leaving a fresh, cherry fragrance.
- Specially formulated to clean woven and non-woven carpets of both synthetic and natural fibres.
- For use with either hot or cold water carpet extraction machines.
- Can be used to pre-spray heavily soiled areas before shampooing and as a spot cleaner.
- For use on a wide range of colourfast carpets and upholstery.
- Developed to rapidly cut through grease and heavy soiling and able to suspend soiling for easy machine extraction.
- For spray application, use with a labelled Cleanline **T7** Carpet Cleaner bottle.
- 5 litre bottle made in the UK from at least 40% recycled HDPE.

RECOMMENDED DILUTION: For application via a carpet cleaning machine or spot cleaning.

Carpet Extraction Machine:	Dilute up to 1 in 50 parts water	Add 20ml per 1 litre of water.
Carpet/fabric spot cleaning and pre-spraying:	Dilute 1 in 20 parts water	T7 Trigger spray bottle: Add 50ml to 600ml of water.

ENSURE YOU ARE WEARING RECOMMENDED PERSONAL PROTECTIVE EQUIPMENT (PPE) AND HAVE THE CORRECT EQUIPMENT FOR THIS TASK.

Carpet Extraction Cleaning: Always test for colour fastness in an inconspicuous area before use. Remove all furniture and vacuum the carpet thoroughly. If necessary, pre-treat the area to help remove spots and stains before cleaning. Fill the tank with prepared diluted solution. Shampoo the carpet in accordance with the machine manufacturer's instructions. Re-set the carpet pile by gently brushing in one direction with a stiff, synthetic carpet brush and allow to air dry. When dry vacuum the carpet thoroughly to remove any dried foam and loosened dirt.

TIP: THE DRYING PROCESS IS THE MOST IMPORTANT STEP IN THIS CLEANING METHOD. AS IT DRIES, THE FOAM ABSORBS THE SOIL AND SETS UP THE SOIL BARRIER TO RETARD THE RE-SOILING OF THE CARPET PILE IN USE.

IMPORTANT: TEST MATERIAL COMPATIBILITY IN A SMALL, INCONSPICUOUS PLACE BEFORE USE TO ENSURE THE DYE OF THE FABRIC DOES NOT RUN
