INSTRUCTIONS FOR USE:

Removing Chewing Gum: Apply direct to contaminated area and allow up to 5 minutes contact time. If the surface has hardened to form a crust, scratch with a blunt knife to enable the product to penetrate soiling. Carefully scrape up the softened residues and then gently scrub the area with a nylon brush dampened with Chewing Gum Remover and wipe with a clean cloth.

For heavily soiled pavement areas, it is recommended that a steam cleaner or pressure washer be used to wash down after spot treating with the chewing gum remover.

Sticky Labels: Apply directly to the area and allow contact time. Scrape off the softened label and using a soft cloth, nylon scouring pad or plastic scraper. Wipe the area clean with a cloth dampened with Chewing Gum Remover.
